Payment terms:

Each child registers by submitting a registration form to the preschool office. The term is reserved after the payment of CZK 1,000 through a pro-forma invoice by 1 May at the latest. In order to get a binding registration of a camp participant, you need to pay the full price for the camp on the basis of a final invoice by 31 May. In case of a bank transfer, the payment symbol will be the invoice number. The pro-forma and final invoices will be sent to the legal guardian's contact e-mail. In case applicants fail to come through with payments, the reservation advance will be forfeited without any claim for remuneration. In case the child's participation is cancelled at least 4 weeks before the selected term, the Provider returns the payment paid to the full extent back to the bank account. The aforementioned conditions do not apply to those who will participate of one or two weeks of the summer camp within the program Duhovka ALL INCLUSIVE. Only payment for catering applies to ALL INCLUSIVE participants.

Representations of the legal guardian:

The legal guardian undertakes to be accessible at the above mentioned telephone number during the whole period of the Child's attendance at the Summer Camp and to inform Mateřská škola Duhovka, s.r.o. about any change in his/her contact data as well as in contact data of authorized person(s) without delay.

The legal guardian undertakes to inform Mateřská škola Duhovka, s.r.o. in writing on the first day of the Child's attendance at the Summer Camp at the latest, of the Child's total state of health, special needs, allergies and all other circumstances which might affect the care for the Child; otherwise Mateřská škola Duhovka, s.r.o. shall not be held responsible for any possible aggravation of the Child's state of health.

The legal guardian confirms that he/she has acquainted himself/herself with the Summer Camp service conditions and health and safety conditions and has agreed to them.

Consent to personal data processing:
